**PRETRIAL ORDER # 231  
(Order re: Mandatory Settlement Conference for  
Additional Covidien LP, Sofradim and TSL Plaintiffs)**

For reasons appearing to the court, it is **ORDERED** that in the cases listed below with claims against Covidien LP<sup>1</sup> (“Covidien”), Sofradim Production SAS<sup>2</sup> (“Sofradim”) and/or Tissue Science Laboratories Limited<sup>3</sup> (“TSL”)<sup>4</sup>, the court will conduct mandatory settlement conferences beginning on **January 11, 2017, at 9:00 a.m.** in Room 7800 and continuing from day-to-day thereafter:



It is **ORDERED** that (1) individual plaintiffs whose cases are scheduled for a settlement conference shall appear in person for the settlement conference and, if represented, with counsel of record as reflected on the docket sheet for that plaintiff's individual case; *and* (2) any plaintiff who fails to comply with this PTO may be subject to a substantial sanction, including dismissal with prejudice. Finally, it is **ORDERED** that if the parties reach a settlement in any of the above cases, submission of an inactive docket order for that case will relieve plaintiff and her counsel from the obligation of attending the mandatory settlement conference.

The Court **DIRECTS** the Clerk to file a copy of this order in 2:10-md-2187 **and in the cases identified above** and it shall apply to each member related case previously transferred to, removed to, or filed in this district, which includes counsel in all member cases up to and including civil action number 2:16-cv-11364. In cases subsequently filed in this district, a copy of the most recent pretrial order will be provided by the Clerk to counsel appearing in each new action at the time of filing of the complaint. In cases subsequently removed or transferred to this Court, a copy of the most recent pretrial order will be provided by the Clerk to counsel appearing in each new action upon removal or transfer. It shall be the responsibility of the parties to review and abide by

all pretrial orders previously entered by the Court. The orders may be accessed through the CM/ECF system or the Court's website at [www.wvsd.uscourts.gov](http://www.wvsd.uscourts.gov).
