ORDER LIFTING STAY OF CONDITIONAL TRANSFER ORDER

A conditional transfer order was filed in this action (*Hughes*) on March 27, 2003. Prior to expiration of that order's fifteen-day stay of transmittal, plaintiffs in *Hughes* submitted a notice of opposition to the proposed transfer. Plaintiffs in *Hughes* have now notified the Panel that they withdraw their initial opposition to the conditional transfer order.
