**ORDER LIFTING STAY OF CONDITIONAL TRANSFER ORDER**

A conditional transfer order was filed in these two actions (*Fabiano* and *Combs*) on June 4, 2003. Prior to expiration of that order's fifteen-day stay of transmittal, plaintiffs in *Fabiano* and *Combs* filed notices of opposition to the proposed transfer. Plaintiffs in *Fabiano* and *Combs* have now notified the Panel that they withdraw their initial oppositions to the conditional transfer order.

IT IS THEREFORE ORDERED that the stay of the Panel's conditional transfer order designated as "CTO-9" filed on June 4, 2003, is LIFTED insofar as it relates to these two actions, and thus the actions are transferred to the Southern District of West Virginia for inclusion in the coordinated or consolidated pretrial proceedings under 28 U.S.C. § 1407 being conducted by the Honorable Joseph R. Goodwin.
