SUMMARY DESCRIPTION

The United States District Court for the Southern District of West Virginia is seeking a Request for Quote (RFQ) for **Open Market Pricing** for wood shutters for our courthouse in Bluefield.

The wood shutters are for the following:

- 4 Palladian windows approximately 15 feet tall (top to have fan type shutter)
- 6 windows in chamber space approximately 74 inches tall

A rough drawing is attached for your convenience; however, the measurements may not be exact and vendor must perform onsite measurements prior to ordering the shutters from the manufacturer.

There is no loading dock at this location. The Courtroom and chamber is located on the second floor and is accessible via stairs and small elevator.

REQUIREMENTS

- Finish to be custom matched to the wood panels on the courtroom walls and in chambers, respectively.
- Contractor shall be responsible for final accurate measurements for each window
- Contractor shall be responsible for inspecting wood shutters prior to installation.
- Shutters panels and louvers must be able to be opened and closed.
- Shutters must be manufactured, completed and installed by December 2016 (pending construction completion). The Court will provide construction updates.
- Delivery and installation at the Elizabeth Kee U.S. Courthouse in Bluefield, WV, must be coordinated with the U.S. District Court, Suzette Redford or Kris Gerencir.
- Vendor must remove and dispose of all packing.







Work Room


