**PRETRIAL ORDER # 294  
(Order Re: Mandatory Settlement Conference for Certain Unresolved Cases)**

Pursuant to Pretrial Order # 293, counsel recently provided a joint written report to the court identifying those cases, totaling 74, with claims against C. R. Bard, Inc. (“Bard”) that remain in the Bard MDL despite good faith discussions contemplated in PTO # 293 over the past thirty days. The parties also identified 24 additional unresolved cases filed against Bard in other mesh MDLs where plaintiffs are represented by the same counsel as those representing plaintiffs in the cases identified in PTO # 293. Finally, the parties identified 53 cases from the original PTO # 293 list that have been resolved and are pending dismissal.

In PTO # 293, I stated that by today, I would enter an order identifying the cases wherein a mandatory settlement conference will be conducted on November 7, 8 and 9 and such other date as set by the court. Upon consideration of the written report submitted to the court, which contains the original 74 cases that remain pending from PTO #293 as well as the additional 24 cases that remain unresolved, and for the

convenience of the parties, counsel and the court, it is **ORDERED** that the settlement conferences will be conducted as follows:


1. For the cases identified on Exhibit A, attached hereto, the court will conduct a mandatory settlement conference in those cases beginning on **November 7, 2018, at 9:00 a.m.** in room 6200B and continuing from day-to-day thereafter.
2. For the cases identified on Exhibit B, attached hereto, the court will conduct a mandatory settlement conference in those cases beginning on **November 8, 2018, at 9:00 a.m.** in room 6200B and continuing from day-to-day thereafter.
3. For the cases identified on Exhibit C, attached hereto, the court will conduct a mandatory settlement conference in those cases beginning on **November 9, 2018, at 9:00 a.m.** in room 6200B and continuing from day-to-day thereafter.

It is further **ORDERED** that (1) individual plaintiffs whose cases are scheduled for a settlement conference shall appear in person for the settlement conference with counsel of record as reflected on the docket sheet for that plaintiff's case; and (2) any plaintiff who fails to comply with this PTO may be subject to a substantial sanction, including dismissal with prejudice. Finally, it is **ORDERED** that if the parties reach a settlement in a case listed on Exhibits A, B or C, submission of an inactive docket order for that case will relieve plaintiff and her counsel from the obligation of attending the mandatory settlement conference.

Finally, it is **ORDERED** that the cases identified as resolved and pending dismissal, identified in the attached Exhibit D, must be dismissed by **January 11, 2019**.

The Court **DIRECTS** the Clerk to file a copy of this order in 2:10-md-2187 **and in the cases identified on Exhibits A, B, C, and D.** It shall be the responsibility of the parties to review and abide by all pretrial orders previously entered by the Court.
