
**PRETRIAL ORDER # 104  
(Coloplast Wave 2 Cases)**

By PTO # 100, the parties submitted a joint list of cases that remain in MDL 2387. By PTO # 102, as amended by PTO # 103, the court entered a docket control order on 240 cases where Coloplast is the only defendant and the parties agree that the cases remain unsettled. These cases are known as the Coloplast Wave 1 cases. The parties also submitted a second list which includes cases on which the parties are unable to agree. The court has removed all cases from this list except ones where Coloplast is the only defendant named. It is attached as Exhibit 1 and contains 250 cases. It is **ORDERED** that on or before **July 1, 2016**, the parties attempt once again to agree as to whether the cases on Exhibit 1 are settled, i.e., covered by an executed master settlement agreement, and submit a revised list of cases to the court via email reflecting the cases on Exhibit 1 that remain unsettled.

The Court **DIRECTS** the Clerk to file a copy of this order in 2:12-md-2387. In cases subsequently filed in this district after 2:16-cv-05113, a copy of the most recent pretrial order will be provided by the Clerk to counsel appearing in each new action at the time of filing of the complaint. In cases subsequently removed or transferred to this Court, a copy of the most

recent pretrial order will be provided by the Clerk to counsel appearing in each new action upon removal or transfer. It shall be the responsibility of the parties to review and abide by all pretrial orders previously entered by the Court.
