## AMENDED ORDER

At its September 2022 session, the Judicial Conference of the United States approved an increase to the maximum page per original and copy transcript fee rates for fiscal year 2024, effective October 1, 2023. By Order entered on September 15, 2023, this court published the newly effective rates. Thereafter, on September 19, 2023, the Administrative Office advised that the Judicial Conference had approved significant changes to the transcript category names at its September 2023 session.

Accordingly, the Court's prior Order is amended and the following Schedule of Maximum Transcript Rates for all categories of transcript for fiscal year 2024 is as follows:

Realtime Translation A draft unedited transcript produced by a certified realtime reporter as a byproduct of realtime to be delivered electronically during proceedings or immediately following receipt of the order.  Orders placed on or before the day of the proceeding will be batched together for purposes of determining the number of fees; and subsequent orders will be charged at the lowest page rate assessed on the previous orders.	One feed <sup>1</sup> , \$3.40 per page; two-to-four feeds, \$2.35 per page; five or more fees, \$1.65 per page.	n/a	n/a
