## PRETRIAL ORDER # 141 (Amendment of Pretrial Order # 66 as to Sofradim and TSL)

As stipulated and agreed to by the parties, the court hereby **ORDERS** that Pretrial Order # 66, Paragraph 1.h., is amended and shall read as follows<sup>1</sup>:

1.h.i. If defendant C. R. Bard, Inc. receives a PPF in the allotted time but the PPF is not substantially complete, defendant's counsel shall send a deficiency letter within 10 days of receipt of a PPF, as applicable by email and U.S. mail to Plaintiffs' Co-Lead Counsel and the plaintiffs' individual representative counsel, identifying the purported deficiencies. Plaintiff shall have twenty (20) days from receipt of that letter to serve a PPF that is substantially complete in all respects. This letter shall include sufficient detail for the parties to meet and confer regarding the alleged deficiencies.

1.h.ii. If defendants Sofradim or TSL receive a PPF in the allotted time but the PPF is not substantially complete, defendant Sofradim's or defendant TSL's counsel shall send a deficiency letter by email or U.S. Mail to Plaintiffs' Co-Lead Counsel and the plaintiffs' individual representative counsel, identifying the purported deficiencies. Plaintiff shall have twenty (20) days from receipt of that letter to serve a PPF that is substantially complete in all respects. This letter shall include sufficient detail for the parties to meet and confer regarding the alleged deficiencies.

The Court **DIRECTS** the Clerk to file a copy of this order in 2-10-md-2187 and it shall apply to each case previously transferred to, removed to, or filed in this district, which includes counsel in all member cases up to and including civil action number 2:14-cv-26603. In cases subsequently filed in this district, a copy of the most recent pretrial order will be provided by the

Clerk to counsel appearing in each new action at the time of filing of the complaint.
