## PRETRIAL ORDER # 263 (Sixth Amended Docket Control Order – Wave 4 Cases

**Third Amended Docket Control Order – Wave 5 Cases)** 

On September 8, 2017, I entered a Stipulation and Order to Extend Deadlines in Wave 4 and 5 Cases ("Order") [ECF No. 4484]. The parties had requested an additional extension of the deadlines remaining in the Wave 4 and Wave 5 cases due to Hurricane Irma and its aftermath, including the closure of the Florida offices of counsel for the defendant, C. R. Bard, Inc. The parties had stipulated to extend the Dispositive and *Daubert* Motions deadlines, including responses and replies. This Docket Control Order does not change any of the deadlines stipulated in the Order, but rather allows those deadlines to be made public as a docket control order on the court's website and to be filed in the designated Wave 4 and Wave 5 cases.
