
**PRETRIAL ORDER #214**  
(Order Instructing Clerk to Remove Mis-filed )

Pending before the court is Non-Parties Sigma Law Firm, LLP, Alpha Law LLP, The Law Offices of Albert J. Lazo, P.A., Martindale Voight LLP, and Pegasus Law LLP, Law Firm Headquarters, LLC, Michael Chhabra, and Ronald Lasora's Motion to Quash Subpoenas Issued by American Medical Systems, Inc., and for a Protective Order. (ECF No. 2205). On May 12, 2016, defendant American Medical Systems, Inc. ("AMS") filed its response with attached Exhibits. (ECF No. 2294). Counsel for defendant subsequently notified the court on May 16, 2016, that a confidential one-page document, (ECF No. 2294-1 at 260), had been incorrectly and unintentionally included in the pages filed as Exhibit 33. AMS requested an order from the court directing the Clerk to remove the one-page document from the record and destroy same. Counsel for defendant also informed the court that all interested parties to the motion were in agreement that the document should not have been included with the attached Exhibit and consented to have the Clerk remove the document from the record and destroy it. Counsel supplied verification of the parties' agreement to the removal and destruction of the document.

Accordingly, the court **ORDERS** the Clerk to remove the first page of Exhibit 33, (ECF No. 2294-1 at 260) from the record and to destroy the document. The parties are also **ORDERED** to remove the designated page from their copy of AMS's response and destroy the document.

The court **DIRECTS** the Clerk to file a copy of this order in 2:12-md-2325 and it shall apply to each member related case previously transferred to, removed to, or filed in this district, which includes counsel in all member cases up to and including civil action number 2:16-cv-4388. In cases subsequently filed in this district, a copy of the most recent pretrial order will be provided by the Clerk to counsel appearing in each new action at the time of filing of the complaint. In cases subsequently removed or transferred to this court, a copy of the most recent pretrial order will be provided by the Clerk to counsel appearing in each new action upon removal or transfer. It shall be the responsibility of the parties to review and abide by all pretrial orders previously entered by the court.
