PRETRIAL ORDER # 121
(Motion to Amend Master Complaint)

Pursuant to Federal Rule of Civil Procedure 15(a)(2), for reasons appearing to the court, and upon consideration of the arguments of the parties, the court **GRANTS** the plaintiffs' Motion for Leave to File Amended Complaint. [ECF No. 987].


The court **DIRECTS** the Clerk to file the Second Amended Master Long Form Complaint [ECF No. 987-1]. The court further **DIRECTS** (1) the plaintiffs to serve the defendants with the Second Amended Master Long Form Complaint on or before **April 14, 2017**; and (2) the defendants to respond to the Second Amended Master Long Form Complaint within fourteen days after service of the Second Amended Master Long Form Complaint in accordance with Rule 15(a)(3) of the Federal Rules of Civil Procedure.

The court further **DIRECTS** the parties to submit a joint list identifying all cases in the Coloplast MDL wherein the plaintiff makes a claim against the defendant(s) as to the biologic products, Suspend-Tutoplast Processed Fascia Lata

and/or Axis-Tutoplast Processed Dermis, and to **email the joint list¹** to **kate_fife@wvsd.uscourts.gov** on or before **April 17, 2017**. Immediately upon identification of the cases alleging claims as to the biologic products, the court will enter a scheduling order in such cases.

The court **DIRECTS** the Clerk to file a copy of this Order in 2:12-md-2387 and it shall apply to each member related case previously transferred to, removed to, or filed in this district, which includes counsel in all member cases up to and including civil action number 2:17-cv-02126. In cases subsequently filed in this district, a copy of the most recent pretrial order will be provided by the Clerk to counsel appearing in each new action at the time of filing of the complaint. In cases subsequently removed or transferred to this court, a copy of the most recent pretrial order will be provided by the Clerk to counsel appearing in each new action upon removal or transfer. It shall be the responsibility of the parties to review and abide by all pretrial orders previously entered by the court. The orders may be accessed through the CM/ECF system or the court's website at www.wvsd.uscourts.gov.
