**PRETRIAL ORDER # 143  
(Order Re: Mandatory Settlement Conference for Certain Unresolved Cases  
December 4 and 5, 2018)**

Pursuant to Pretrial Order (“PTO”) # 140, counsel recently provided a joint written report to the court identifying those cases with claims against Coloplast Corporation, RTI Biologics and/or Mentor Worldwide LLC (collectively “Coloplast”) that remain in the Coloplast MDL despite good faith discussions contemplated in PTO # 140 over the past several weeks. In PTO # 140, I stated that on or shortly after November 12, 2018, I would enter an order identifying the cases wherein a mandatory settlement conference will be conducted on “December 4 and 5, 2018 or such other dates as set by the court.” PTO # 140, p. 2. Upon consideration of the written report submitted to the court and for the convenience of the parties, counsel and the court, it is **ORDERED** that the settlement conferences will be conducted as follows:


1. For the cases identified on Exhibit A, attached hereto, the court will conduct a mandatory settlement conference in those cases beginning on **December 4, 2018, at 9:00 a.m.** in room 6200B and continuing from day-to-day thereafter.

2. For the cases identified on Exhibit B, attached hereto, the court will conduct a mandatory settlement conference in those cases beginning on **December 5, 2018, at 9:00 a.m.** in room 6200B and continuing from day-to-day thereafter.
3. For the cases identified on Exhibit C, attached hereto, these cases have been identified as resolved and pending dismissal by the parties. The parties in these cases need not attend this mandatory settlement conference, but must dismiss and close their cases by **January 11, 2019**, or an in person show cause hearing will be set.

It is further **ORDERED** that (1) individual plaintiffs whose cases are scheduled for a settlement conference shall appear in person for the settlement conference with counsel of record as reflected on the docket sheet for that plaintiff's case; and (2) any plaintiff who fails to comply with this PTO may be subject to a substantial sanction, including dismissal with prejudice. Should any cases on the attached exhibit be closed before the settlement conference, attendance is not required in such case.

The Court **DIRECTS** the Clerk to file a copy of this order in 2:12-md-2387 **and in the cases identified on Exhibits A, B and C.** It shall be the responsibility of the parties to review and abide by all pretrial orders previously entered by the Court.
