**PRETRIAL ORDER # 159
SHOW CAUSE ORDER**

On March 13, 2019, this court entered Pretrial Order No. 154, which ordered the following as to all remaining cases in Coloplast Wave 5, 6, 7 and 8:

- a. **Transfer Cases.** By no later than **April 6, 2019**, the parties shall meet and confer concerning the appropriate venue for each of the Transfer Cases, and the parties are **ORDERED** to file a joint venue recommendation by **April 13, 2019**, indicating each transfer venue for direct filed Transfer Cases. The parties must identify for each Transfer Case: (1) the agreed venue or disputed venue; (2) plaintiff's counsel of record; (3) plaintiff's city and state of residence; and (4) state of plaintiff's implant and any removal(s).
- b. **Remand Cases.** For Remand Cases received from the Panel, the parties are **ORDERED** to file a joint list identifying the remand jurisdictions to which each Remand Case must be returned as indicated on the court's docket by **April 13, 2019**.

In piecemeal, incomplete filings at ECF Nos. 2429, 2430 and 2431, the parties have failed to comply with this court's order. The court expected the parties to file one joint document containing the above information in each of the Coloplast Wave 5, 6, 7 and 8 cases that remain open on the court's docket. The parties' representation that cases have been settled does not excuse compliance with the order in the cases remaining on the court's docket. **The submission of this**

information as directed by the court is essential to the planned remand or transfer of the remaining cases.

The court **ORDERS** that plaintiffs' leadership and counsel for **ALL** defendants named in cases in Wave 5, 6, 7 and 8 are directed to show cause in writing in each individual case, why they should not be sanctioned pursuant to Rule 16(f) of the Federal Rules of Civil Procedure for failing to comply with my Order by **Wednesday, May 22, 2019**. The court has attached Exhibit A, which contains the remaining cases in Coloplast Waves 5, 6, 7 and 8. As a courtesy, the court has attached Exhibit B, containing the cases (1) in Coloplast Wave 9 and (2) other MDL waves now in the Coloplast MDL. The court will schedule a hearing at a later date.

The Court **DIRECTS** the Clerk to file a copy of this order in 2:12-md-2387 and in each case in Coloplast Waves 5, 6, 7 and 8 and send a copy of this order to counsel of record and any unrepresented party in each case in Coloplast Waves 5, 6, 7 and 8.


