PRETRIAL ORDER # 82 (Order: Mandatory Settlement Conference for Certain Cook Plaintiffs)

Pursuant to Pretrial Order # 80, counsel recently provided a joint written report to the court identifying those cases with claims against Cook Incorporated, Cook Biotech, Inc., and Cook Medical, LLC (formerly known as Cook Medical, Inc.) ("Cook") that remain in the Cook MDL despite good faith discussions contemplated in PTO # 80 over the past several weeks. In PTO # 80, I stated that by today, I would enter an order identifying the cases wherein a mandatory settlement conference will be conducted beginning July 18, 2017 "and continuing from day-to-day thereafter." 2:13-md-2440, ECF No. 501, Pretrial Order # 80, p. 1. Upon consideration of the written report submitted to the court, the court **ORDERS** that for the cases identified on Exhibit A, mandatory settlement conferences will be conducted beginning on **July 18, 2017, at 9:00 a.m.** in Room 7800 and continuing from day-to-day thereafter.

The court further **ORDERS** that (1) individual plaintiffs whose cases are scheduled for a settlement conference shall appear in person for the settlement conference with counsel of record as reflected on the docket sheet for that plaintiff's individual case and any pro se plaintiffs must also appear in person; and (2) any plaintiff who fails to comply

with this PTO may be subject to a substantial sanction, including dismissal with prejudice.

The court **ORDERS** that counsel for defendants provide a copy of this PTO to any pro se

plaintiff on Exhibit A and file a proof of mailing. Finally, the court **ORDERS** that if the

parties reach a settlement in a case listed on Exhibit A, submission of a dismissal order for

that case will relieve plaintiff and her counsel from the obligation of attending the

mandatory settlement conference.

The Court **DIRECTS** the Clerk to file a copy of this order in 2:13-md-2440 and in

the cases identified on Exhibit A and it shall apply to each member related case previously

transferred to, removed to, or filed in this district, where applicable, which includes counsel

in all member cases up to and including civil action number 2:17-cv-00071. In cases

subsequently filed in this district, a copy of the most recent pretrial order will be provided

by the Clerk to counsel appearing in each new action at the time of filing of the complaint.

In cases subsequently removed or transferred to this Court, a copy of the most recent

pretrial order will be provided by the Clerk to counsel appearing in each new action upon

removal or transfer. It shall be the responsibility of the parties to review and abide by all

pretrial orders previously entered by the Court. The orders may be accessed through the

CM/ECF system or the Court's website at www.wvsd.uscourts.gov.
